

Madison Russian School
Waiver and Release

I acknowledge that my child is voluntarily participating in programs offered by Madison Russian School, Inc. ("School"). I understand that there are risks associated with my child's participation in the School's programs, such as physical or psychological injury, illness, temporary or permanent disability, death, and economic loss. These injuries or outcomes may arise from my child's or others' actions, inactions, negligence, or the condition of facilities. **NONETHELESS, EXCEPT TO THE EXTENT CAUSED BY THE RECKLESS OR INTENTIONAL CONDUCT OF THE SCHOOL, I ASSUME ALL RISKS OF MY CHILD'S PARTICIPATION IN THE SCHOOL'S PROGRAMS AND PRESENCE ON OR ABOUT THE SCHOOL PREMISES,** whether known or unknown to me, including travel to and from the School or any events incidental to my child's participation in the School's programs; risks may include, without limitation, emotional or physical injuries, exposure to infectious diseases or communicable illnesses (including, without limitation, the COVID-19 virus), exposure to environmental conditions, food allergies or food poisoning, injuries from physical activities, injuries due to vehicles or equipment (including, without limitation, playground equipment), fires or smoke, adverse weather conditions (including, without limitation, excessive heat or cold, rain, flooding, ice, snow, wind, tornadoes, lightning, or severe thunderstorms), sunburn, insect bites or stings, or theft or damage to belongings or other property.

By signing this agreement, on behalf of my child, myself, and our respective heirs, representatives, executors, administrators, agents, insurers, successors, and assigns, I accept and assume full responsibility for any and all injuries, illness, damages (both economic and non-economic), and losses (including, without limitation, any physical or mental injury, illness, or death), that my child or I may incur to the extent they are not caused by the reckless or intentional conduct of the School, and, on behalf of my child, myself, and our respective heirs, representatives, executors, administrators, agents, insurers, successors, and assigns, **EXCEPT TO THE EXTENT CAUSED BY THE RECKLESS OR INTENTIONAL CONDUCT OF THE SCHOOL, I HEREBY WAIVE AND FULLY AND FOREVER RELEASE AND DISCHARGE** Madison Russian School, Inc., and its directors, officers, employees, volunteers, insurers, independent contractors, agents, representatives, attorneys, successors, and assigns (collectively, "Released Parties"), from any and all liabilities, losses, claims, demands, damages (both economic and non-economic), costs, expenses, rights of action, and causes of action (including, without limitation, any physical or mental injury, illness, or death), present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from, or arising out of, my child's participation in the School's programs and attendance at, use of, or presence in, on, or about, the School premises, but only to the extent they are not caused by the reckless or intentional conduct of the School. In the event of any emergency, I authorize the Released Parties to provide first aid to my child and to secure from any licensed hospital, clinic, urgent care center, physician, or medical personnel any treatment deemed necessary for my child's immediate care, and I agree that I will be responsible for payment of all medical services rendered. However, nothing contained herein shall be construed to create an actual or implied duty upon the Released Parties or other third-parties to provide or seek such first aid or medical treatment for my child.

This Waiver and Release shall be effective and binding upon my child and me, and our respective heirs, representatives, executors, administrators, agents, insurers, successors, and assigns. Should any of the provisions set forth in this Waiver and Release be determined to be invalid by a court, agency, or other tribunal of competent jurisdiction, I agree that such determination shall not affect the enforceability of other provisions of this Waiver and Release.

I am not relying on any oral or written representations or statements made by the School or any representative of the School with respect to the nature of this Waiver and Release.

I REPRESENT AND WARRANT THAT: I AM AT LEAST EIGHTEEN (18) YEARS OLD; I AM THE PARENT OR GUARDIAN OF THE CHILD IDENTIFIED BELOW; I HAVE READ AND UNDERSTAND THE FOREGOING WAIVER AND RELEASE OF LIABILITY; I HAVE HAD THE OPPORTUNITY TO ASK QUESTIONS, REQUEST CHANGES OR CLARIFICATIONS; AND I VOLUNTARILY EXECUTE THIS DOCUMENT WITH FULL KNOWLEDGE OF ITS CONTENTS.
